FIRST TIME/NEW PASSPORT FOR APPLICANTS AGE 16 AND OVER

ELIGIBILTY:

- YOU ARE APPLYING FOR YOUR FIRST U.S. ADULT PASSPORT OR
- YOUR PREVIOUS U.S. PASSPORT WAS ISSUED WHEN YOU WERE UNDER AGE 16 OR
- YOUR PREVIOUS U.S. PASSPORT WAS ISSUED MORE THAN 15 YEARS AGO.

YOU MUST BRING THE DOCUMENTS LISTED BELOW AND APPEAR IN PERSON AT YOUR LOCAL ACCEPTANCE AGENT. THEY WILL WITNESS YOUR SIGNATURE AND THEN SEAL EVERYTHING IN A SEALED ENVELOPE, YOU WILL HAVE FIVE DAYS TO PRESENT THE SEALED ENVELOPE TO THE PASSPORT AGENCY FROM THE DAY IT WAS SEALED.

- 1. APPLICATION FORM DS-11 (CLICK HERE) MUST BE COMPLETED ONLINE AND PRINTED OUT WITH THE 2-D BAR CODE ON IT.
 - DO NOT SIGN THE DS-11 APPLICATION UNTIL THE ACCEPTANCE AGENT HAS ASK YOU TO DO SO.
 - IF THE APPLICANT IS 16 OR 17 YEARS OF AGE WITHOUT A VALID DRIVER LICENSE, A LEGAL GUARDIANS' SIGNATURE IS REQUIRED ON THE APPLICATION DS-11, SO ONE OF THE PARENTS WOULD NEED TO COME IN WITH THERE STATE ISSUED DRIVER LICENCE/ID.
- 2. ORIGINAL CERTIFIED COPY OF YOUR U.S. BIRTH CERTIFICATE THAT WAS ISSUED BY THE STATE WHERE YOU WERE BORN, ORIGINAL EXPIRED U.S. PASSPORT, <u>OR</u> ORIGINAL NATURALIZATION CERTIFICATE. (<u>CLICK HERE</u>) FOR MORE DETAILS.
- **3.** ONE (1) COLOR PASSPORT TYPE PHOTOGRAPH (2"x2") WITH A WHITE BACKGROUND NO GLASSES. (CLICK HERE) FOR MORE DETAILED PHOTO REQUIREMENTS.
- 4. TWO ORIGINAL TYPED LETTER OF AUTHORIZATIONS (ONE INSIDE THE SEALED ENVELOPE AND ONE ON THE OUTSIDE OF THE SEALED ENVELOPE. *(SEE BELOW)*
- 5. \$205.00 YOU WILL NEED TWO SEPERATED PAYMENTS IN THE AMOUNT OF \$170.00 CHECK/MONEY ORDER AND MADE PAYABLE TO THE "US DEPARTMENT OF STATE" AND THEN AN ADDITIONAL \$35.00 CASH/CREDIT CARD. THE DEPARTMENT OF STATE DOES NOT ACCEPT TEMPORARY CHECKS.
- **6.** PROOF OF INTERNATIONAL DEPARTURETHAT SHOWS YOU DEPARTING WITHIN 2 WEEKS OR 4 WEEKS IF YOU NEED A TRAVEL VISA TOO.
 - CONFIRMED TRAVEL ITINERARY; OR
 - COMPANY LETTER OF EXPEDITE (SEE BELOW FOR EXAMPLE)
- 7. YOUR VALID DRIVER LICENSE OR VALID STATE ISSUED I.D.
